ATRM/NCB/13/077/78 Bidding is open to all eligible as per Section V of bidding document..
2. *Aathrai Tribeni Rural Municipality* invites sealed bids or electronic bids from eligible bidders for the construction of 10 Bed hospital under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Aathrai Tribeni Rural Municipality, Hangpang, Taplejung** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document of NRs 5,000.00 (Five Thousand Rupees only) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids..



7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before 12:00 PM on 2021/06/08.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2021/06/08 at the office of *Aathrai Tribeni Rural Municipality, Hangpang*. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 38,00,000/-, which shall be valid for 30 days beyond the validity period of the bid.
